WHEREAS, The Monroe County Water Authority ("Authority") intends to provide public eater service to 0 North Street Road located in the Town of LeRoy; and

WHEREAS, the acquisition of the easement is necessary for operation, maintenance and the future replacement of the water main which will allow the Authority to continue to reliably provide potable water supply to the area; and

WHEREAS, the easement is located along the frontage of 0 North Street Road (Tax Acct. No. 22.0-1-30.111), which is owned by Stephen A. Cottone; and

WHEREAS, § 1096(6-A) of New York's Public Authorities Law requires the Authority to obtain the prior approval of the Town Board for the above-referenced acquisition; now therefore be it

RESOLVED, that the Town hereby approves of the Authority's acquisition of the frontage easement located at 0 North Street Road in accordance with § 1096(6-A) of the New York Public Authorities Law and be it further

RESOLVED, that a copy of this resolution be provided to the Authority.
